Purpose

Background

Records of your contact with us as via the phone, online, email;

Information which we obtain from the Credit Reference Agency including public and shared credit history, financial situation and financial history.

Does RRRL do any monitoring involving processing of personal information?

RRRL may monitor where permitted by law. The information monitored may be shared for business purposes within the company with the Directors and staff and externally with any authorised Government body that requires the information held, i.e. HMRC.

How long does RRRL retain personal information?

For as long as we have reasonable business needs, such as managing our relationship with you and managing our operations;

For as long as we provide and/or are provided with goods and and/or services;

Retention periods in line with legal and regulatory requirements or guidance.

What are your rights under data protection laws?

The right to be informed about the processing of your personal information;

The right to have your personal information corrected if it is inaccurate and completed if incomplete;

The right to object to RRRL processing your personal information;

The right to restrict processing of your personal information;

The right to have your personal information erased (the right to be forgotten);

The right to request access to your personal information;

The right to move, copy or transfer your personal information (data portability);

Consent

Consent is required by RRRL to process all types of personal data, but it must be explicitly given.

By consenting to this Privacy Policy, you are giving RRRL permission to access any personal data held specifically for the purpose identified in the policy.

Disclosure

RRRL will not pass on your personal information to third parties.
